INGREDIENTS: Water, glucose syrup, sugar, dextrose, natural flavors. Here below further specifications about:

Lemon: citric acid, Sicily Lemon juice concentrate, natural flavor made with essential oils from a Lemon variety named "primo fiore di Sicilia".

Black cherry: citric acid and black cherry concentrate.

Orange: citric acid, concentrated juice of Sanguinella Orange, a variety from Sicily, natural flavors, and essential oils from typical sicilian oranges.
